The Admission Fee will be collected through **SB Collect** only. No other mode of payment is acceptable. For payment, the applicants are required to visit **SBI COLLECT -> EDUCATIONAL INSTITUTIONS -> ODISHA -> DIRECTOR NIT ROURKELA -> Admission Fee for PhD Programme**. After successful payment download the e-Receipt for SB Collect Payment.

For admission, the candidates are required to bring the following documents in **ORIGINAL** alongwith a set of self-attested copy of each certificate:

- a) Signed copy of application form downloaded from <http://eapplication.nitrkl.ac.in>.
- b) Marks sheets/Grade Cards of all examinations from Class - X onwards
- c) Degree / pass Certificates from Class - X onwards
- d) College leaving/Transfer Certificate in **Original**, if applicable
- e) Migration Certificate of last studied institute in **Original**.
- f) Conduct Certificate of last studied institute in **Original**.
- g) OBC-NCL/SC/ST/PWD Certificate, if applicable. (OBC-NCL/EWS certificate issued on or after **1<sup>st</sup> April, 2025**).
- h) GATE/NET/GPAT etc. Score Card, if applicable
- i) ABC ID Proof.
- j) Fellowship sanction letter if selected under External Fellowship category.
- k) Relieving letter for the candidates who are in service/working.
- l) Two (02) Recent Passport size colour photographs
- m) **Printout of e-Receipt of SB Collect payment for ADMISSION FEE.**

<b>STEP – 2</b>	Go to <b>"Pay Admission Fee"</b> link and fill up the transaction details of payment made for admission fee in SBI Collect and submit.

**Refund of Fee:**

If a student is removed or withdraws/leaves himself/herself from the Institute after admission without completing the entire program, all fees paid including the caution money deposit will be forfeited by the Institute. Mess advance may be refunded after deduction of dues, if any. This clause is applicable even before formal registration to the 1<sup>st</sup> semester and starting of classes.

**Location:**

Rourkela is located in the Howrah-Mumbai main Train route. Train connections are also available from Bhubaneswar and Ranchi. Night AC/Non-AC bus services are available from all major cities of Odisha (Bhubaneswar/Berhampur/Balasore, etc.). The Institute is located around 8 km. away from the Railway Station and 2 km away from Sector-3 Bus Stop. Usual rate of auto fare at present is Rs.150/- to Rs. 200/- and Rs. 100/- respectively.
