- Candidates are required to report to the respective Departments at 9:00AM on <u>5th June, 2025</u> (<u>Thursday</u>). The selection process may consist of either written or oral tests or both. It is expected that the test/interview will be completed by the end of the day. However, if it will not be completed on the same day, it will continue on the next day. Please make your return reservations accordingly.
- 4. Candidates applied under sponsored category, if selected, will be required to stay at NIT Rourkela till completion of their programme. Such candidates need to produce leave for at least three years with M.Tech/M.Pharm degree and four years with all other degrees from the

sponsor at the time of admission.

- 5. Candidates working outside Rourkela will not be considered for Local Sponsored category. If interested, their cases may be considered for sponsored category on production of proper sponsorship certificate.
- 6. Category of studentship mentioned in the application will be decided after interview and verification of documents.
- 7. The candidates are required to keep the following original documents ready to produce the same before the selection committee on demand:
 - a) Marks sheets/Grade Cards of all examinations from Class Xth onwards.
 - b) Degree / pass Certificates from Class Xth onwards.
 - c) GATE/NET/GPAT etc. Score Card, if applicable.
 - d) Sponsorship Certificate from employer in the prescribed format for Sponsored candidates.
 - e) Research papers/publications, if any.
