NOTICE

National Institute of Technology, Rourkela intends to engage one **CONSULTANT (AUDIT)** on contractual basis to assist and advise the Institute in undertaking different Audit activities. Accordingly, the Institute invites applications from Central Govt./Central Autonomous Bodies/CAG Officials who have been recently retired from the services.

Eligibility:

Central Govt./Central Autonomous Bodies/CAG Officials who have been recently retired from the capacity of Section Officer/AAO and above with Grade Pay of Rs.5,400/- (Level-9) and above. The persons should not above 63 years of age as on the date of walk-in-interview.

Duties and Responsibilities:

1. Preparation of suitable reply for compliance to old and outstanding CAG Paras.
2. Liasoning and follow-up work with CAG Office and other relevant Govt. offices for settlement of the audit observations. Providing of suitable advice and guidance to minimize the audit observation during SAR and Transaction audit.
3. Any other assignment depending upon administrative requirements.

Remuneration:

During Contract period, the pay will be regulated as per government guidelines on the fixation of pay for re-employed pensioners subject to ceiling limit of Rs.50,000/- per month. The amount of remuneration so fixed shall remain unchanged for the term of Contract.

Terms and Conditions:

1. The candidate selected will be engaged purely on contractual basis initially for a period of one year w.e.f. the date of joining and will not confer any right for regular appointment to any permanent position at NIT, Rourkela. The consultancy period may be extended at the discretion of the Competent Authority subject to functional requirement, performance appraisal, fitness of individual etc. However, the maximum period of engagement will be for a period of three years or up to 65 years of age, whichever is earlier.
2. The Institute reserves the right to terminate the engagement by serving 15 days notice on the Consultant

3. The employee shall abide the Institute Rule meant for the Contractual Appointment.
4. During outstation work the TA/DA shall be provided as per institute rule.
