B. POLICY AND IMPORTANT ADMINISTRATIVE MATTERS.

BOG-67(2020)-03: Recruitment of Faculty.

The interview for faculty recruitment against Advertisement No.NITR/ES/01/2019, dt.26.02.2019 for Back Log Vacancy and Advertisement No.NITR/ES/02/2019, dt.27.02.2019 for Regular Vacancy was conducted from dt.04.12.2019 to dt. 24.01.2020 are Attached (P/74 - 85). The list of successful candidates recommended by the Selection Committees is put up for approval.

After being satisfied with the procedures adopted as per Statutes and MHRD regulation and maintaining the norms for reservation policy, the Board approved the recommendations of the Selection Committee which was put up on the table. The report of the committee was put to the BOG in its 65th Meeting held on 01.10.2019. The Board noted the matter awaiting the version of the suspect officer and decided to put up the matter in the next BOG meeting along with the version of the suspect officer and comments of the CVO of the Institute, at present Registrar.

Now, the report of the committee along with the version of the suspect officer received from NIT Patna and the comments of the CVO of the Institute is put up for the comments/recommendation of the BOG, the Disciplinary Authority in this case. Based on the recommendation of the Disciplinary Authority, the *First Stage Advise* is to be asked from the CVC.



E. MISCELLANEOUS ITEMS:

BOG-67(2020)-07: Proposed to build 02 nos. of International standard Asphalt based Synthetic Flooring Lawn Tennis Court and 01 no. of Basketball Court.

It was proposed to build 02 nos. of International standard Asphalt based Synthetic Flooring Lawn Tennis Court and 01 no. of Basketball Court to provide better sports facilities to the students. In this regard CPWD submitted an Estimate of Rs.1,49,08,000.00, when the agencies was contacted by NIT Rourkela. This proposal was recommended by the Building & Works Committee(BWC) and was placed before the 49th Finance Committee (FC) meeting as an Agenda Item No. FC-49 (2019)-07, dt.21.06.2019.

As per the resolution of the Finance Committee, the members felt that the estimated cost of the project is in higher side and there is a need to reduce it by truncating some of the Features/Items after due consultation with the CPWD and the Chairman, BOG was authorized to approved the changed estimate [vide item No. FC-49 (2019)-07, dated.21.06.2019].

After due consultation with CPWD, the revised estimate for the said work was worked out as Rs.98,21,700.00. The detail revised estimation by CPWD for this wok is enclosed in the Annexure.

The Chairman, BOG, approved the above proposal.
