F.C-34(2015)-01: The Chairperson to welcome all members present.

Chairperson welcomed all the members to the 34th meeting of the FC and leave of absence was granted to the member(s) who could not attend.

F.C-34(2015)-02: Confirmation of the minutes of the 33rd Meeting of the Finance Committee and Action Taken Report thereon.

The item, was deferred due to non-availability of the final minutes and action taken report on the minutes. Administration was advised to prepare the final minutes of the 33rd Meeting of the FC along with ATR on those

minute and present to the FC in its next meeting.

F.C-34(2015)-03: Financial Status of the Institute.

The financial status of the Institute as on 30.11.2015 is given in the Annexure for information of the FC.

The FC noted the financial status and advised the administration to present the sources of funds and a detailed break-up to account for the negative balance (overspent amount) of Rs. 114 crores.

F.C-34(2015)-04: Payment of scholarship during the 5th year to the Ph. D students with M. Tech or equivalent qualification.

Ministry of HRD vide F. No. 17-2/2014-TS.I, dated 24/11/2015 has clarified that Ph. D students with M. Tech or equivalent qualification are also to be paid scholarship during their 5th year. This change (earlier they were paid only for 4 years) is effective from 01-10-2014.

Accordingly, it is proposed to pay scholarship for the 5th year to all those Ph. D students with M. Tech or equivalent qualification who were in receipt of scholarship as on the effective date, i.e. 01-10-2014. Estimated financial implication for current year and arrears will be 3.5 crore rupees.

The FC approved the proposal for M. Tech. qualified Ph. D scholars and advised the administration to take up the cases of MBA/M.Sc./MA qualified Ph. D scholars with MHRD.

A proposal was put up vide Agenda Item No. - F.C-33(2015)-09 to the 33rd FC held on 26/10/2015. As was advised, the proposal is put up with justification in numeric terms.

Justifications for Hostel Seat Rent [SI. No. 1 to 3] of the above:

- = 7,00,000 / 30 = 23,3331. Depreciation cost of building per year
- 2. Maintenance Cost @ 1% of 7,00,000 per year = 7,000Total attributable (theoretically) expenses for Seat Rent > 30,000

However, raising the Seat Rent suddenly by such large amount may invite criticism. Hence, a practical smaller rate is proposed.



Justifications for Establishment Charge [Sl. No. 4]:

However, raising the Medical Fee suddenly by full amount may invite criticism. Hence, a practical smaller rate is proposed.

The FC deliberated the above proposal and approved the following:-

- I. To increase the fee as given in the Approved Fee Column.
- II. "Deferred revenue" expenditures incurred for installation/fitting as well as replacement of hot water supply system, curtains, kitchen equipment, etc. to be met from Hostel Seat Rent in the future in place of Establishment Charge as is being done at present.
- III. To process work orders for first time installation/fitting of curtains, hot water system and kitchen equipment from institute funds against seat rent received and to be received in future.

F.C-34(2015)-08: Report on fraud committed by an external training agency.

One faculty (Prof. S. K. Das, Civil Engg.) and one officer (Mr. H. Satapathy, Engineer) were nominated to attend one international training program organised by an organization named Engineers Development Council, New Delhi vide O. O. No. – NITR/ES/2013/M/2995, dated 04/12/2013.

The training fee of Rs. 4,72,000/- was paid by the institute from TEQIP-II account for the same purpose in advance to the organization as the Brochure and letter head of the agency mentioned that the agency is established by the Planning Commission.

The agency, however postponed the schedule quite a few time. Apprehending a possible fraud, Mr. Satapathy got in touch with Niti Aayog and to his utter surprise was informed that the agency was a fraud and the aayog had published a public notice vide No. A.43011/31/2013-ADM.I. dated 14-03-2014.

In view of above it has been decided to inform about the payment to the Niti Aayog and also to lodge an FIR with the local police. Further developments will be appraised to the FC from time to time.

It is proposed that the advance may be delinked from the employees account and be treated as an advance paid by the Institute.



The FC noted the incident and advised the administration to set up a committee to look into the whole issue and suggest proper action to be taken in the instant case and to avoid such occurrence in the future.

It was further advised to take up the matter with Niti Aayog and to lodge an FIR in the local Police Station if not already filed by Niti Aayog.

F.C-34(2015)-09: Including Raipur Airport in the permitted list for Air Travel.

The BoG vide Resolution No. – BOG- (20)-xx, dated have permitted the airports at Bhubaneswar, Ranchi and Kolkata for air travel on the groud of being in home state, nearest geographically and nearest metro city, respectively.

Representation has been received to include Raipur Airport also in the list on the following grounds:-

- a. Travelling to New Delhi / Mumbai / Hyderabd from Raipur is cheaper and takes less time than other three cities.
- b. Distance to Raipur from Rourkela is comparable to Kolkata/ Bhubaneswar.

The representation was examined and found acceptable.

The FC approved the proposal to include Raipur along with Ranchi, Kolkata and Bhubaneswar for taking flights to other parts of the country.
