Confirmation of the Minutes of the 36<sup>h</sup> Meeting of the Finance Committee held on 16.12.2016 at New Delhi.

FC-37(2017)-03:

Report on Action Taken on the Minutes of the 36<sup>th</sup> Meeting of the Finance Committee.

The 'Action Taken' Report on the Minutes of the 36<sup>th</sup> Meeting of the Finance Committee was given in Annexure for information of the FC.

The 'Action Taken' Reports on the decisions taken in the 32<sup>nd</sup>, 33<sup>rd</sup> and 34<sup>th</sup> Meetings of the FC had to be put up in this Meeting of the FC, which has not been done. The FC expressed its concern at this and desired that the requisite 'Action Taken' Reports be positively put up in the next meeting of the FC.

The 'Action Taken' Report on the decisions taken in the 36<sup>th</sup> Meeting of the FC was noted with the following observations:

- FC-36(2016)-10: The compliance has been indicated as 'Implemented' which is incorrect. Firstly, the approval for advertising the post of Medical Officer provisionally for a period of one year had to be sought from the Board of Governors, before advertising the post. Secondly, the proposal for restructuring/reclassification of the non-teaching posts had also to be put up before the Finance Committee, which has not been done. The FC desired that the same be put up for the consideration of the Finance Committee in its next Meeting.
- ☐ FC-36(2016)-11: The matter regarding terminal benefits and monthly pension of Prof. Swaroop Kumar Mohapatra had to be put up in this Meeting with full details, which has not been done. The FC desired that the same be put up for the consideration of the Finance Committee in its next Meeting.

The Finance Committee further observed that the 'Action Taken' Report should have the requisite details, wherever required, instead of just mentioning 'Implemented' or 'Under Process' against each decision.

FC-37(2017)-04:

Financial Status of the Institute.

The financial status of the Institute as on 31<sup>st</sup> December, 2016 along with details of negative balance (overspent amount) was given in the Annexure for information of the FC. The similar status as on 31<sup>st</sup> January, 2017 was put up on the table.

The FC noted the above and advised the Institute to be prudent to rationalize the expenditure in view of the financial crisis. It was again emphasised that the intake of students in its various programmes be rationalized.

The FC further observed that the Finance Committee be informed in its next meeting as to whether a loan was taken from some Banks in view of the precarious financial situation of the Institute, a few years back or not.

FC-37(2017)-05:

Revised Estimate for the Financial Year 2016-17 and Budget Estimate for Financial Year 2017–18.

The Revised Estimate for the Financial Year 2016-17 and Budget for the Financial Year 2017–18 were given in Annexure-A4.

The FC recommended the Institute to revise the 2016-17 Budget within Rs. 170 Crore which is the expected Grant-in-Aid to be received in the Financial Year 2016-17 and the Budget for 2017-18 in the range Rs. 220-230 Crore.

The FC advised the Institute to collect information on the Policy on Corpus Fund utilization being followed in some other NITs and some IITs including IIT, Kanpur and put up in its next meeting after suitable modifications, if any required.

FC-37(2017)-07:

Proposal for Best Teacher award with a cash prize of 1 lakh for present and past teachers.

It was proposed in the meeting of 156<sup>th</sup> Meeting of HODs and Deans to institute the Best Teacher award with a cash prize of Rs. 1 Lakh for the present and past teachers every year.

The FC recommended to the Board of Governors, the above proposal for the existing faculty members only and further suggested to consider

giving non-pecuniary lifetime achievement award(s) to the best teacher(s) from among those who have superannuated. It was also suggested to consider issuing certificates of appreciation to three teachers based on student feedback every semester. The FC clarified that all these awards are to be based on teaching performance only and should be presented every year on the Teacher's Day (i.e., September  $5^{th}$ ). The FC desired that the proposal alongwith modalities of its implementation may be put up before the BOG in its next Meeting.

The FC had under Agenda Item No. FC-36(2016)-10 of its 36<sup>th</sup> meeting, had recommended only the Post at Sl.#1 provisionally for a period of one year to the Board of Governors, considering the need of the Institute and advised the administration to put up the proposal for restructuring/reclassification of the non-teaching posts before the Finance Committee and the Board of Governors of the Institute for consideration.

It was informed that at present, each faculty member is entitled to reimbursement from PDA under the following heads:

As per the Resolution taken in the 51<sup>st</sup> Meeting of the Deans and Heads on 01-06-2016, the following proposals are submitted regarding utilisation of PDA:

- 1. A faculty member may be allowed to reimburse his expenses on page charges for publication in SCI/ SSCI/ Webscience/ Scopus Journals.
- A faculty member may be allowed to reimburse towards purchase of books and membership fee up to Rs.50,000/- each in a period of 3 years. The membership may be of more than two societies. Online purchase of books is encouraged and reimbursement will be made including shipping charges.
- 3. The conference participation evidence is necessary for the reimbursement of conferences charges from PDA.
- 4. The direct purchase portal will be made available to all faculty members for reimbursement of spent amount on any head.

The FC observed that the CPDA guidelines of the Ministry are already there and all the NITs are following it. Moreover, the Standing Committee of the Council of NITs has been working on framing new CPDA guidelines in consultation with all the NITs. Accordingly, it was felt that the Institute should wait for the new guidelines rather than taking any action at its own end.
