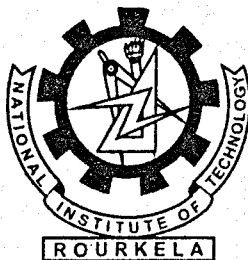

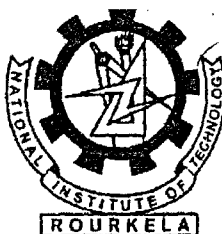

**A. RULES, PROCEDURES, CURRICULA AND POLICY MATTERS:**

**2013-43-Senate-04: Policy on Erasmus Mundas Scholarship Scheme for students:**

NIT Rourkela by signing an agreement has become an official partner of HERITAGE programme of the Erasmus Mundas Partnership (EMA2 strand1) Project funded by the European Commission and coordinated by Ecole Centrale Nante, France. Under this program, students of NIT Rourkela will be sent to different host universities to undergo training/study for the duration required for the programme. Copy of the agreement is given in the annexure.

The last date for submission of application online was 03/02/2013 and till date 77 students had already submitted their applications.

The Senate deliberated on the issue considering the following in general:

- a) Students with low CGPA and having courses with UR, X, I and F grades
- b) Semester evaluation of the students where there is a mismatch between the courses and corresponding credits in the host university.

*The following policy was decided.*

- a) *The students having CGPA 8.00 or above will be considered for Erasmus Mundas Scholarship Scheme.*
- b) *Students having courses with UR/XI/F grade and/or are penalized under ISDC/EDC or by any other means will not be considered.*
- c) *An Equivalence Committee will be formed to take care of the mismatch between the courses and corresponding credits in the host university.*
- d) *Dean(Academic) was authorized to sign the Learning Agreement between the home and host institutions.*
- e) *The scheme will be implemented for students of different programmes as follows:*

**1) B. Tech and Dual Degree B.Tech & M.Tech Programmes:**

*Considering the programme structure and placement facility, B.Tech and Dual Degree B.Tech & M.Tech Students will avail the scheme only in their 6<sup>th</sup> semester for a duration of 6 months at European Union host*

universities. Since the last date for submission of application is 3<sup>rd</sup> February 2013 for mobility in Autumn semester 2013-14, due to the time constraint the current 6<sup>th</sup> semester students (Spring Semester 2012-13) cannot be considered for the Autumn semester 2013-14. However, students who will be in 6<sup>th</sup> semester in Spring 2013-14, will be permitted to process their application in June, 2013 and their mobility will start in February 2014.

**2) M. Tech programmes:**

For the M. Tech students who have completed 1 year at NIT Rourkela, their application will be considered for project work and the duration will be considered for 6/10 months. B.Tech final year students are not permitted to apply for the 1<sup>st</sup> semester of M.Tech. in the host universities.

**3) Ph.D. programme:**

For the Ph.D. students who have completed 1 year at NIT Rourkela, their application will be processed for 6/10/18 months. First year PhD students who have done M.Tech in NIT Rourkela are also eligible to submit application.

**2013-43-Senate-05: To consider the issue of pursuing more than one degree simultaneously and Joint Degree Programme:**

The Institute has received a letter from the UGC to look into the issue of pursuing more than one degree simultaneously from the same university or different universities either through distance mode / part-time mode and awarding of a Joint Degree by Indian Universities.

The letter and the issues raised by the Expert Committee constituted by the Chairman, UGC was put up in the annexure for deliberation.

The Senate discussed on the above issues and advised that since the Institute is not coming under UGC Act, the proposal was not considered.

**B. UNDERGRADUATE STUDIES**

**2013-43-Senate-09: Grade change of Sri Achinta Roy, Roll No. 110EI0144 in the course EC100:Basic Electronics of Spring semester 2011-12:**

Sri Achinta Roy, Roll No. 110EI0144 had secured F grade in the paper EC100:Basic Electronics in his 2<sup>nd</sup> semester (Spring 2010-11). Subsequently he appeared as backlog in Spring 2011-12 and the course teacher uploaded P grade which was reduced to F due to attendance shortage. No request for the change of grade was received from the department.

On 26<sup>th</sup> December 2012 Academic Office received a request from the department for the grade change of the above students from P to B on the ground that in Spring 2011-12 the uploaded grade was only on the basis of the End-Semester marks and no cognizance for Mid-Sem and TA were taken.

Since the request for change of grade has not been received within 3 weeks from the date of starting of the semester (as per the Academic Regulation), it was put up to the Senate to decide whether the grade change request will be acceptable now after completion of one semester.

*The Senate deliberated on the issue and approved the consideration of TA and Mid-Sem component marks along with End-Sem marks as submitted by the DAC. The grade reduction will be as per rule. Accordingly, the student is deserving to get B grade [(Mid-Sem = 19.5) + (End-Sem = 40) + (TA=11) = 70.5]. The grade will be reduced by two steps; one for shortage of attendance and the other for backlog and hence the student will finally secure "D" grade in the course EC100.*


**Item No. 1: Attendance issue for students who have registered late:**



Dear Sir,

Greetings! We are glad to inform that 80 students have so far applied to the HERITAGE project of the Erasmus Mundus. However, in order to complete the online application, students will require a 'Learning Agreement' / 'Work Plan' document from our institute that they must scan and submit online to the HERITAGE. The formats of the 'Learning Agreement' and 'Work Plan' are enclosed. In these documents, our institute need to certify that the courses/research opted by the student in the EU host university is agreeable to our institute and the grades/credits obtained by the student will be transferred upon their return to NITR. The purpose is that, the student should not loose semester and should not face an extension of their study period due to their mobility to EU host university. Following are the recommendations from the HERITAGE team of the NITR in this regard.

**B.Tech**

Upon examining the courses offered by EU host universities, it was observed that there is limited number of courses at EU host universities that closely matches the courses offered at NITR in the respective braches at respective degree levels. Thus, it is very difficult to ensure that the students will be able to find sufficient number of relevant courses at EU host universities to meet the credit requirements at NITR. Thus, following options were considered,

1. If the content of the courses, chosen by the students, closely resembles the courses offered by the NITR in the respective degree level and branch, it may kindly be considered.
2. It may be ensured that the total credits to be obtained by the students at EU host university meets the total credits requirement at NITR in the respective degree level and branch.

**M.Tech - I Year**

For M. Tech first year mobility, B.Tech final year students are eligible to apply. However, there is no way to ensure that our B.Tech final year students will be able to gain entry in a particular branch of NITR. Even if the student is able to gain entry in the NITR, the problems of course and credit requirements are same as stated above for the B.Tech students. Accordantly, our recommendations are the same.

**M.Tech - II Year and PhD**

Since the second year M.Tech and PhD students mainly have research project work, they seem to be the most suitable for mobility. However, following points may need to be considered,

1. The title and credit for the research work at the host EU universities may not match with the title (Research Project) and credit give at NITR. Our institute may kindly consider converting the title and credit to match those of NITR so that the students do not lose any semester.

2. In some cases, the students may not find a relevant course to 'Seminar and Technical Writing' in English. In such situations, students may be advised to attend the seminars in EU host universities and submit the reports and other requirements of 'Seminar and Technical Writing' to the respective course teacher via E-mail. Or, any other alternative may kindly be considered.






In addition to the above, following points may also be considered:

1. HERITAGE program offers mobility for one or more semesters. In cases wherein, the students are going to EU host university for more than one semester, they may not be coming back to India in their inter-semester break. In such cases, alternatives for semester registration such as online registration and fee payment, registration upon their return etc. may kindly be considered.
2. The timing of start and end of semester at NITR does not coincide with the timing of start and end of semester at most EU host university. However, if we combine our semester and vacation duration, then it may be possible (Please see the enclosed chart). For example, in case of 6 months mobility, students can register the spring semester at NITR in Jan 2014, go to EU host university in Feb/Mar 2014 and come back to NITR in July to register and continue the autumn semester at NITR. It appear to us that students may not be able to go to EU host university in Autumn semester for 6 months mobility because the autumn semester in EU host university starts around Sept/Oct and ends in Feb/Mar (including holidays). In case of 10 months mobility, students can register the Autumn semester at NITR in July 2013, go to EU host university in Sept/Oct 2013 and come back at July 2014 to NITR.
3. Third year B.Tech students can apply now but will be able to go EU host university in their Eighth semester. In this case, one need to consider that they will back to NITR in July and therefore, may be missing the T&P.
3. Since the numbers of application are too many (80 so far), the NITR may consider some cut-off mark (to be decided by the NITR) for pre-selecting the students and signing the learning agreement.
4. The institute may also consider the courses and their credits per semester at EU host university as a "bundle package" for equivalence of courses and their credits at NITR to avoid complications of matching the credit/course equivalence.

The last date for online application is 03.02.2013. Thus, an early decision will be of great help to the students.

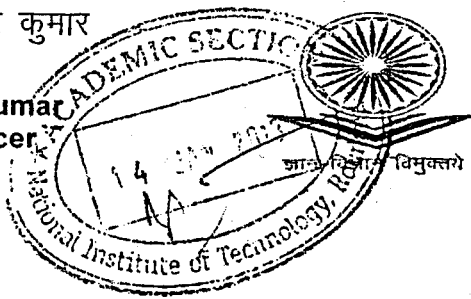

**Minutes of the meeting of the Committee to Consider the Issue of Pursuing more than One Degree simultaneously and Joint Degree Programme.**

A meeting of the Committee to consider the issue of pursuing more than one degree simultaneously and joint degrees was held on 29<sup>th</sup> October, 2012 in the UGC Head Office.

Following members were present:

Prof. Iqbal Ahmad, Professor of Mathematics, JMI could not attend the meeting. UGC officials assisted the Committee.

At the outset, the Chairman of the Committee welcomed all members and apprised the members with the issues to be taken up.

1. To pursue more than one degree programme simultaneously:

The minutes of the earlier meetings held on 13.05.2011 and 09.07.2012 were perused and discussed by the Committee. The changing scenario of higher education in India and abroad also came in for discussion. The members also discussed the pros and cons of allowing students to pursue more than one degree simultaneously. After a detailed deliberations, following decisions were taken:

- a) A student enrolled in a degree programme under regular mode may be allowed to pursue a maximum of one additional degree programme simultaneously under open/distance mode from the same or a different university. However, two degree programmes under regular mode may not be allowed simultaneously as it may create logistic, administrative and academic problems.
- b) A student pursuing a degree programme under regular mode may be allowed to pursue a maximum of one certificate/diploma/advanced diploma/PG diploma programme simultaneously either in regular or open and distance mode in the same university or from other institutions.

2. Joint Degree Programme:

The issue of awarding Joint Degree by universities within India was also discussed by the Committee and it was felt that apparently nothing prohibit universities to permit their students to take and complete a part of their programme of studies from any other recognised universities and to this extent the joint degree programme are not only permissible by the UGC but also needs to be encouraged. Interested universities may make necessary enabling ordinances specifying details and procedures in this regards and may sign Memorandum of Understanding to execute the award of joint degrees.

Further, the Committee was of the opinion that the minutes may be sent to the Vice-Chancellor of all universities to obtain their comments before taking a final decision in this regards.
