Senate-85[2019]-04: Academic Calendar for the session 2019-20.

Senate-85[2019]-05: Renaming Part-Time MBA to Executive MBA Programme.

Senate-85[2019]-10: Appeal of Terminated Students.

Appeal of the students received till 13 July, 2019 against termination of their studentship on various grounds [CGPA requirement, non-registration, etc.] at the end of Spring 2018-19 semester was presented on the table by the Associate Dean [AA].

Senate deliberated on the cases as presented by the Asso. Dean [AA] and decided as given in the Annexure.

C. RESEARCH STUDIES

Senate-85[2019]-11: Appeal of PhD Scholars for waiver of Semester Registration.

Senate, vide Resolution No. 2019-82-Senate-18, dated 24 April, 2019 has approved the following modifications to the policy of submission of thesis.



- 1) Time limit for submission of Thesis is extended up to six months from the date of Synopsis Seminar.
- 2) The scholar may be allowed to take withdrawal after delivering Synopsis Seminar. However, Semester Registration is to be done with "zero credit" till submission of Thesis.
- 3) Payment of Semester Fee excluding Tuition Fee is mandatory till submission of Thesis. Balance Mess Fee, if applicable, will be refunded by Chief Warden Office, after clearance of hostel by the scholar.

Prior to above, research scholars who were submitting thesis within one month from the due date of Semester Registration were exempted from doing Semester Registration.

Few research scholars who had planned to submit their thesis within one month from the due date of Semester Registration for Autumn 2019-20 have appealed to consider the previous regulation for them.

Senate deliberated on the representation but did not approve.

Senate-85[2019]-12: Change of Supervisor of Ishkiran Singh and Partha Sarathi Mishra.

Consequent upon resignation of Prof. Tuhin Subhra Maparu, DRC of PA department has recommended to change the Supervisor as follows which has been approved by the Dean [AA].

Senate-85[2019]-13: Proposal for instituting a Gold Medal in the memory of Late Sri Kamakshi Prasad Panda [1974 Alumnus].

A proposal has been received from Mr. Ranjeet Mohapatra [2008 Alumnus] and Mrs. Priyanka Panda [2008 Alumnus] to donate Rs. 10.00 lakhs to institute a Gold Medal to be awarded to the Best Graduate out of EE, EC and CS. Their proposal has been vetted by the Senate sub-committee headed by Dean [AIIR]. Copy of the proposal and vetting is given in Annexure.



Senate deferred the item and advised Dean [AllR] to put up a consolidated report on all the endowment awards/medals along with their financial position.

E. MISCELLANEOUS:

Senate-85[2019]-14: Merging of APOC with IQAC.

In view of the fact that mandate and responsibility of Academic Programme Oversight Committee [APOC] and Institute Quality Assurance Cell [IQAC] are almost similar to each other, Director has approved to merge the existing APOC with the newly formed IQAC with following arrangements:

- a. All members of existing APOC be made members of IQAC.
- b. Senate has nominated Prof. S. K. Rath [CS] as the first Chairman of IQAC. Accordingly, Prof. S. Bhattacharyya may be relived as Chairman of APOC by handing over charge to Chairman, IQAC.

Further, the Director has approved to nominate Prof. R. K. Patel [CY] in place of Prof. S. Jena [PH] in the APOC/IQAC.

Senate ratified above.

Senate-85[2019]-15: Any other matter with permission of the Chair:

- 1. Core Committee for XVII Convocation [2019 Batch].
 - In the preliminary meeting held for XVII Convocation, Director desired/proposed the following:-
 - a. Hon'ble President of India Shri Ram Nath Kovind to be invited as the Chief Guest for XVII Convocation.
 - b. Asso. Dean [AA] to be included in the Core Committee as an Exofficio Member,
 - c. Prof. K. K. Mahaptra, Ex-Dean [AA] to be a Special Invitee to the Core Committee to co-ordinate Chief Guest for the XVII Convocation

Senate approved the proposal.

2. Adoption of Image Model for data uploading to NAD Portal.

There are two models for uploading of data [Certificates and Mark-Sheets] to the NAD Portal. NAD Cell has proposed to adopt the Image Model for the purpose in order to ensure resemblance with the physical copies. CVL also suggested to go for Image Model for convenience.

Senate approved the proposal.



3. Extension of Studentship of Sarat Chandra Chaini.

Studentship of Sarat Chandra Chaini is expiring on 17 July 2019. DSC has recommended for extension of his studentship by one year.

Senate granted extension up to 30 June 2020.

4. Nomination of Board Member.

As per Section 11(f) of the NITSER Act, 2007, Board of Governors of the Institute *inter-alia* constitutes two nominees of the Senate – One Professor and One Asso./Asst. Professor. Prof. C. R. Patra, Professor [CE] is one of the Senate nominee to the BoG for two years from 22.08.2017 to 21.08.2019. Accordingly his term will be over on 21.08.2019.

As per the Senate Resolution No.2007-16-Senate-03, dated 24.12.2007 following has been decided (reproduced below):

- a) Selection of Board members will be through secret ballot only by the senators on a particular date decided by the Senate. There shall be no proxy vote or remote voting via telephone, email or post.
- b) One of the Senators will act as the Returning Officer who will keep the nomination files and conduct the election. The Returning Officer will not contest in the election, but will be eligible to vote.
- c) Ordinarily, the Chairman, Senate will not cast his vote. But in case of tie, he will cast his vote to break the tie.
- d) Once a member is elected, he can contest for another term after a gap of at least two years from the date of the expiry of his membership.
- e) Prof. S. Ghosh was nominated as Returning Officer for this year's election only.
- f) As a one-time measure, external Senate members may send their vote to Director, which will be used only if they will have a decisive effect on the results.

Senate nominated Prof. S. K. Patel [ME] as the Returning Officer for conduction of the election for BOG member.
