## **MINUTES**

Senate-86[2019]-01: Welcome to the members and invitees by the Chairman, Senate.

The Chairman, Senate welcomed all the members and invitees to the 86<sup>th</sup> meeting of the Senate. The newly nominated Senate members were also welcome.

Senate-86[2019]-02: To confirm the minutes of 85<sup>th</sup> meeting of the Senate.

The draft minutes of 85<sup>th</sup> meeting of the Senate held on 15 July, 2019, provisionally approved by the Chairman, Senate has been circulated to all members by groupmail.

Senate confirmed the minutes with modifications/additions as given in Annexure.

Senate-86[2019]-03: Report on Action Taken on the decision of 84<sup>th</sup> meeting of the Senate.

The report on the action taken on the decisions made in the 84<sup>th</sup> meeting of the Senate held on 07/06/2019 as given in the Annexure was discussed.

Senate noted the report.

Senate-86[2019]-04: Proposal of Student Nominees in the Senate.

The proposal submitted by Mr. Soumya Ranjan Mohanty, Roll No. 715MN1153, a student nominee in the Senate was put up for discussion.

Senate deliberated on the matter and opined the followings:

- marjāqu ca

- Issues related to Centralized Instrumentation Facility: It should not be an agenda for discussion in Senate. However, Prof. Mahabir Panda(PIC-CIF) assured to sort out the problem soon. One additional feature will be added in online portal to indicate unserviceable equipment.
- 2. <u>NPTEL/SWAYAM/Industry oriented courses</u>: As approved earlier by the Senate, credits earned by the students through such courses will be transferred up to maximum 20% as recommended by Credit Transfer Committee.
- 3. <u>Establishment of Centres of Excellence and labs with aid from Industry</u> and Government: Actions are being taken by the Institute in this matter.
- 4. <u>Internship for Dual Degree or M.Tech students</u>: As per earlier Senate resolution, this is being permitted if the concerned supervisor agrees.
- <u>Uploading of Evaluation Scheme</u>: The solution sheet for at least the core courses along with evaluation scheme should be circulated among all students.
- 6. <u>Feedback system issue</u>: Feedback system will be made online from the current session i.e Autumn 2019-20.
- 7. <u>Late Registration Attendance issues</u>: The present practice of resolving this issue as per academic regulations shall continue.

### Senate-86[2019]-05: Proposal to have a policy for conversion of CGPA to percentage.

Currently, the Institute follows CGPA method and there is no policy for conversion of CGPA awarded to percentage. A notice to this effect is available in the website. However, few students and alumni have been approaching the Institute requesting to have a policy for conversion citing that many recruiters like Army/Navy/Air Force and few PSUs require score in percentage only and as a consequence they are not able to participate in their recruitment processes.

Accordingly, it is proposed to have a policy to convert the CGPA to percentage by multiplying the CGPA by 10 [e.g. 6 CGPA = 60 %].

Senate approved the above proposal with the following modifications:

- i) The policy for conversion of CGPA to percentage will be (CGPA-0.5)\* 10
- ii) The conversion formula will be mentioned on the grade sheet.
  - iii) The medium of instruction will be mentioned on the Degree certificate as English except for the language courses.

#### A. RULES, PROCEDURES, CURRICULA AND POLICY MATTERS

Senate-86[2019]-06: Policy for extending duration of Institute fellowship against approved leaves of research scholars.

As per existing policy, research scholars are permitted to avail up to 15 days of absence in an academic year with fellowship. However, they are permitted for remaining absence for certain other compelling reasons like family calamity, illness, etc. Scholars apply for leave of absence and the same is considered for approval on case to case basis depending upon the reasons and/or documents in support of the leave of absence. However, they are not paid fellowship during such leaves (beyond 15 days in a year).

Further, as per existing policy, the period of payment of fellowship is fixed for 5 years from the date of commencement which is not extended even if the scholar(s) avail leave under compelling grounds beyond their control.

Accordingly, it is proposed to extend the period of payment of fellowship beyond 5 years by an equal number of days for which leave of absence is approved by the competent authority as per existing policy. However, the concerned scholar need to submit an application for the same duly recommended by the Supervisor and forwarded by the concerned HOD.

Senate approved the proposal but without exceeding actual payment for 60 months of fellowship to any student.

Senate-86[2019]-07: Proposal for starting Integrated PhD Programme in Chemistry.

A proposal has been received from the HOD [CY] for starting Integrated PhD Programme in Chemistry from the Academic Year 2020-21. The proposal is given in the Annexure.

Senate advised the HODs of all Science departments to come up with a common proposal.

Senate-86[2019]-08: Proposal for considering criteria of Degree Awarding
University/Institution for admission to PhD Programme.

Institute criteria for admission to PhD Programme is 60% marks or 6.5/10 CGPA throughout career. Some universities/Institutes award First Class in



the UG Programmes based on 60% mark in the Honors subjects only instead of considering all subjects. There are instances, where an applicant has been awarded First Class in UG but does not have 60% marks in aggregate if all subjects are considered.

It was proposed by Dean [AA] to admit such candidates provisionally in the Autumn 2019-20 Semester subject to final decision of the Senate in this regard which was approved by the Director. The candidates have been provisionally admitted after submission of an undertaking to this effect.

Senate did not approve the proposal and resolved to cancel the provisional admission of all such students on the basis of guidelines mentioned in the advertisement.

Senate-86[2019]-09: Proposal of M/s Edureka to partner with the Institute to introduce an on-line M.Tech. Programme.

A proposal has been received from M/s Edureka to partner with the Institute to introduce an on-line M. Tech. Programme. Copy of the proposal was given in Annexure. The Senate has already approved for such on-line Degree Programmes vide Resolution no. 2019-82-Senate-09, dated 23/05/2019. UGC has also permitted for online courses from July 2019 onwards. #### C. RESEARCH STUDIES

Senate-86[2019]-12: Recommendation of 48th RPEC.

48<sup>th</sup> RPEC was held on 21 October 2019 to review the cases of Enrollment, Provisional Registration and Registration of M. Tech. (R) and PhD students. Minutes containing the recommendations was given in Annexure.

Senate approved the cases from A to G and deferred rest of the cases i.e. from G to I since these cases need to be re-examined.

Senate-86[2019]-12: Report of the extended DRC and DSC in the matter of D V Anantha.

In view of conflict reported between D V Anantha, Roll No. 514CR1002 and his Supervisor, an extended DRC was formed by the Director to examine the case and he was asked to present his research progress before the extended DRC and DSC.

After going through the report submitted by the extended DRC and DSC, Dean [AA] also submitted his report to the Director. Director desired to place the matter before the Senate [copy given in Annexure].

Senate agreed with the proposal of the committee to terminate the studentship of D.V Anantha.

Senate-86[2019]-14: Proposal for offering LS613 in place of HS7301.

Research Methodology [HS7301] was made a compulsory course for the PhD students of LS department against Mathematics. Three students [518LS217, 518LS6015 and 518LS601] could not clear the course by spring 2018-19. The course is no more offered by the HS department. Accordingly, HOD [LS] requested that these three students be allowed to take Research Methodology [LS613] offered by LS department. The proposal was approved by the Director.

Senate ratified the approval.

Senate-86[2019]-15: Proposal for allowing departmental course in place of Compulsory Mathematics course of MA department.

Mathematics was made a compulsory course for the PhD students of all departments except HS and LS. Few students could not clear the course by Spring 2018-19. Both the courses are no more compulsory and are not offered by the MA department for students of other departments. Accordingly, Dean [AA] proposed that such students be allowed to take any other relevant course offered by their departments. The proposal was approved by the Director.

Senate ratified the approval.

Senate-86[2019]-12: Appeal of Deelip Kumar Rautray for admission to Executive PhD.

Deelip Kumar Rautray, an applicant for the Executive PhD programme was recommended for admission by the DRC of ME department. At the time of document verification on the day of admission, it was observed that he does not have 60% mark in aggregate of all years of B. Tech. as required for admission. He submitted an appeal for considering the qualification based on only final year as per the policy of his University. His appeal was approved by the Director based on the recommendation of Dean [AA] for provisional admission subject to submission of an undertaking to the effect that the matter will be put up to Senate for final decision. Accordingly, he has been given provisional admission subject to final decision of the Senate.

Senate deliberated and resolved to cancel his provisional admission as he does not have 60% marks in aggregate of all years of BTech as per the requirements mentioned in the advertisement for admission.

#### Senate-86[2019]-17: Appeal of Sangeeta Tarai for admission to PhD.

Sangeeta Tarai, an applicant for the PhD programme was recommended for admission by the DRC of EC department. At the time of document verification on the day of admission, it was observed that her M. Tech. specialization [Electronic Information System from Berhampur University] is not a listed specialization for EC department. She submitted an appeal for consideration. Her appeal was approved by the Director based on the recommendation of Chairman, DRC of EC followed by Dean [AA] for provisional admission subject to submission of an undertaking to the effect that the matter will be put up to Senate for final decision. Accordingly, she has been given provisional admission subject to final decision of the Senate.

Senate approved the provisional admission of the student.

Senate deliberated and resolved that Self Defence Training would be imparted to all girl students as a part of their EAA course in the first year.

#### Senate-86[2019]-23: Policy for Executive Ph.D Programme.

First batch of Executive Ph.D. candidates have been admitted and departments have been informed to complete their Enrollment, Prov. Registration and First Semester Registration as per guidelines issued vide Circular No.1499, dated 13.09.2019 (copy given in Annexure). Subsequent to completion of above activities, following need to be decided in general for the Executive Ph.D. Programme:

- a) Whether ID cards will be issued to the candidates?
- b) Whether the candidates will be given Institute email ID?
- c) What will be the mode of examination
  - i) Only End Semester Exam. (80%) + TA (20%), or
  - ii) Mid-Tern (30%) + End Term (50%) + TA (20%) [Note – Time constraint for Mid-Term in Autum 2019 -20 Sem.]
- d) Whether compulsory English will be applicable?
   [Note Only 1 teacher for the course and may be offered in Spring 2019-20, if made mandatory]
- e) Whether Comprehensive Examination will be applicable?

Senate deliberated and resolved that the Executive PhD programme would formally commence from 2019-20 Spring with the following guidelines:

- a) Students will be issued with Id card with Roll No starting from 919.
- b) Institute email id will be provided to the students.
- c) Mode of examination will be same as that for other PhD students.
- d) English will be compulsory and be offered in Spring 2019-20.
- e) Comprehensive Examination will be applicable.
- f) The classes or contact hours, if any, done in Autumn 2019-20 will be considered for Spring 2019-20.
- g) The fees paid by the student in Autumn 2019-20 will be considered towards Spring 2019-20 fees.
